Outsourcing administrative tasks to The Labor Insurance Administration Association

Representation in The Labor Insurance Administrative procedures
Possibility of installment payment of Labor Insurance premiums

Special enrollment in workers' compensation insurance for business owners, executives, family workers, etc. (for small and medium-sized business owners)

Commission fee: 8.36% of the previous year's finalized insurance premium (including tax) (minimum amount 4,400 yen including tax)
Commission fee for general businesses

Rental of meeting rooms, training rooms, and halls
(members receive a 30% discount on general rates, Wi-Fi available)

Information delivery service

Inclusion of flyers and pamphlets in the "Izumo" report, delivered to approximately 2,300 businesses

Members 22,000 yen (including tax)

Issuance of certificates of origin and other documents

In cases where certification such as a Certificate of Origin is required for transactions with foreign countries:

Members: Issuance fee is 50% off the regular rate. Registration and renewal fees are free.

Non-members: Both registration and renewal fees are 11,000 yen (including tax).

The Tosho Certification

(a practical certification exam conducted by the Tokyo Chamber of Commerce and Industry, aimed at developing industrial human resources)

All online exams (IBT method: take the exam on your own computer, CBT method: take the exam at test centers nationwide) ... Eco Certification, Welfare and Living Environment Coordinator Certification, etc.

I would like to save money for the future.

Small Enterprise Mutual Aid

A savings system for individual business owners of small enterprises (including co-managers) or company officers, to prepare for cases such as closing down the business or retiring.

Contribution amount

Monthly 1,000 yen to 70,000 yen (in increments of 500 yen)

The full amount of contributions can be deducted from taxable income. If the mutual aid is received as a lump sum, it is treated as retirement income, resulting in a lower tax burden

Business Safety Mutual Aid (Small and Medium Enterprise Bankruptcy Prevention Mutual Aid)

A system that provides loans when a business partner goes bankrupt and accounts receivable claims, etc., become difficult to collect



I would like to secure and retain employees.

Life Mutual Aid

Monthly Premium Starting from 750 yen per unit

Benefits: Death benefit, hospitalization benefit, celebration money, subsidy, consolation money

Special Retirement Allowance Mutual Aid

Systematically prepare for employees' retirement allowances

Monthly Premium Ranging from 1,000 yen to 30,000 yen (in 1,000 yen increments)

The entire premium is deductible as an expense or necessary cost
